INTERPRETER

Points of emphasis:

GK POSSESSION:

What constitutes possession? Hand on ball and ball between hand and ground/body, maybe two fingers. GK out of penalty area or not playing ball with hands makes GK a player.

GAME CLOCK MANAGEMENT:

CLOCK STARTS AFTER BALL RETURNS TO PLAY.

WHEN YC OR RC GIVEN YOU CAN STOP CLOCK.

If time stopped for an injury of the GK, GK must sub out. Team must designate a player to be GK or substitute.

Q & A:

When does referee make decision re: player may have a concussion?

When player exhibits signs of injury that indicate concussion. Send player off for concussion protocol testing. If returned to field watch player for symptoms. If new observations remove player.
