#### **Discussion on Penalty Kick procedures**

### **Discussion on Indirect Kick procedures**

The issue of what is to be done when during an IDK attacking player approaches the ball, taps in on the top, not moving the ball, and another attacking player then kicks the ball. The proper procedure depends on kicks result: If into goal-score nullified as not proper second touch. If in play, touch by any player is "second touch".
